Welcome to the CPAWSB Employer Portal

This guide will provide you with a walkthrough of the basic Employer Portal functions. If further assistance or clarification is required, please contact partnerships@cpawsb.ca.

CPAWSB Employer Portal

The CPAWSB Employer Portal is a self-service portal where employers can:

- Review the CPA academic results for learners in their organization (Note: only learners who have granted consent for their information to be shared with their employer will be visible in the Employer Portal)
- Review all active CPA learners who are currently enrolled in CPA Preparatory courses or the CPA Professional Education Program (CPA PEP)
- Review any outstanding accounts receivable items for CPA learners connected to an employer/organization

Employers who are interested in accessing the Employer Portal must fill out an application that can be found on the CPAWSB website.

Employer Portal Access

Once your Employer Portal profile has been set up through CPAWSB, you will receive an automatically generated email providing you with your username and a link to activate your account and set your personal password. Once your profile has been activated, the portal can be accessed at any time by going to the Employer Portal Login page. The Employer Portal is optimized for Chromium Edge. The Employer Portal does not currently support mobile browsers or mobile operating systems.

Login using the username/email that has been assigned to you (indicated in the activation email) and the password that you have set up through the link in the activation email.





Employer Portal

Welcome to the Employer Portal.

Each organization may have up to a maximum of three (3) administrators and an unlimited number of users assigned with access to the CPAWSB Employer Portal. Administrators are responsible for the set up and management of the organization's administrator and user profiles.

Employer Portal Administrators

A maximum of three (3) administrators may be granted access to the Employer Portal for any organization. Administrators can access the reports and candidate information for all companies/locations within an organization. Administrators are also responsible for adding, editing, and removing any additional user profiles within their organizations. This includes limiting each user's access to run reports for only the applicable companies/locations.

Employer Portal Users

User profiles are added and managed by the organization's administrator(s). A user profile can run available reports, but only has access to the information for the specific companies/locations assigned by the administrator.

User profiles can be added, edited, or removed by the administrator through the User Management section of the Employer Portal.






Employer Portal Home




On the User Management page, select Add New User.






Welcome to User Management. Here, Administrators can add, edit or delete Administrator and User profiles. Organizations can assign up to three Administrators and unlimited Users. Administrators can add, edit, or delete Users within their organization as needed and can access and download reports for all office locations within an organization. Users can only access and download reports for office locations assigned by the Administrator.



Enter the required profile information, indicated by the red asterisk (*). If the profile you are setting up is one of the three (3) Administrators permitted for the organization, ensure that the "Administrator Privileges" box is checked. If you are setting up a User profile, leave this box unchecked.




All available companies/locations within the organization will be listed. For a new administrator profile, check the box at the top of the column for each report type (CPA Module Registrations, Active CPA Learners, and Outstanding AR Listing) to select reports for all companies/locations. For new user profiles, check the box for each report next to each specific location listed to limit the access to only the specified locations.

Once an administrator or user profile has been set up, the details (including contact information and administrative privileges) can be edited, or the entire profile deleted, from the User Management page.

Once logged in, administrators and users can access the reports that are available through the "Reports" link in the menu on the Employer Portal home page.

This report displays module and examination **registrations** and **results** for candidates in the CPA Professional Education Program (CPA PEP) and students registered in CPA preparatory courses.





Module and CFE Results


Module and CFE results are released according to the CPA PEP schedules.

Note: The report shows only a summary of final results. Candidates who pass only one component of the CFE (e.g., either Day 1 or Day 2/3, but not both) will be listed as an overall "Fail" on this report until both components have been successfully completed.

To access module and CFE results, please follow the instructions below:

- 1. Login using the username/email assigned to you from your activation email.
- 2. Run the **CPA Module Registrations** report with the following parameters:




